
In accordance with the Law of the Republic of Kazakhstan 'On the Securities Market,' since July 1, 2023, the registration of securities is a set of measures, including the registration of new securities and the updating of existing ones.

Since July 1, 2023, the KCSD Personal Account has been a SINGLE ENTRY POINT for all local issuers to register their securities issues.

- Securities Issues Registration (Equities, Bonds, Mutual Funds)
- >> Updating/Renewing the Terms of Securities Issues (Equities, Bonds, Mutual Funds)
- >> Approval of Reports on the Results of Equity Offerings, Equity Exchanges, and Splits
- >> Development Centers for the Cancellation of Securities Issues



The operator of the services is the Agency of the Republic of Kazakhstan for Regulation and Development of the Financial Markets.

Digital Web Forms for the Prospectus

- Automatic generation of electronic application forms and securities prospectuses, and attachment of electronic copies of documents.
- Documents can be saved indefinitely in the Personal Account's database.

Online Process Tracking

- Monitoring by the issuer of the status of acceptance, processing, and execution of submitted applications.
- The option to withdraw an application on its own initiative.

Automated Data Migration

 Automatic migration of information about registered securities issues into the KCSD core system.

Dedicated Data Storage

 Data stored in the Personal Account's database as a result of the registration process: certificates of state registration for the securities issue, notifications, and refusals.

Synchronization of the Securities Databases

 Synchronization of information about securities contained in the KCSD system with the State Register of Securities.



Since 2023, part of the CA (10% stakeholders, splits, equity exchanges, mergers) has been provided by KCSD instead of the issuer.




Information Disclosure
